

## MASTER IN HUMAN RIGHTS AND CIVIL LIBERTIES

**In Italy** there is a progressive growth of active participation in the national landscape. Today, many people want to combine their skills and civil passion and want to work, or are already working, within NGOs, associations, organizations involved in the field of human rights and civil liberties. Across Europe, many organizations work on human rights and civil liberties and need more skilled staff to work on advocacy, policy, and strategic litigation. **At the same time**, human rights are increasingly a topic of interest for academics and researchers, who often struggle to find interdisciplinary education opportunities around it.

**The Master** aims to fill this gap, and form a leading class of people engaged in human rights and civil liberties.

#### **GENERAL INFORMATION**

The Master is aimed at an international cadre of students. All lesson will be held in English.

Lessons will start in February and end in May. They will take place on Friday and Saturday. A three-month (unpaid) internships will be available for every student in leading organisations working in the areas of human rights protection, civil liberties promotion, humanitarian assistance, either at the national or international level.

#### **TUITION FEE**

The tuition fee for the full Programme is **3,000** euros, payable in two installments (first installment:  $\in$  1,800; second installment:  $\in$  1,200)

#### **REQUIREMENTS AND APPLICATION DEADLINE**

Candidates must fulfil these minimum requirements:

(1) Have a three-year (at least) university degree or equivalent

(2) Understand, speak and write English at least at LEVEL C1, (CEFR for Languages, CoE)

The application deadline is 22nd December 2017
